# THE ESTABLISHMENT OF THE STATE OF PALESTINE FROM THE PERSPECTIVE OF SIYASAH SYAR'IYYAH

#### **INTRODUCTION**

The Palestinian-Israeli conflict is one of the longest-running conflicts in human history. Human rights are the most fundamental rights of all human beings on earth. This means that every right and obligation of human beings must be respected and fully implemented in order to realize the concept of human rights as it should be. The concept of human rights is spread across various dimensions of life, one of which is in the context of war and conflict between countries. This concept is reflected in the 1949 Geneva Convention, which provides protection rights for militants and civilians in war zones. A total of 196 countries have ratified the

Convention, one of which is Israel. This means that in the conflict between Israel and Palestine, Israel, as a ratifying party, is obliged to respect what is stated in the convention. However, in practice, Israel has violated many articles to the extent that it has committed a list of war crimes mentioned in the convention. This evidence serves as a form of validation for the International Court of Justice to adjudicate the case in order to restore the rights and dignity of the victims. According to Palestinian health officials, more than 46,000 people were killed in the Gaza war, out of a total population of around 2.3 million before the war.

In the past two years, an estimated 64,000 children have been killed or seriously injured across the Gaza Strip, including at least 1,000 infants. The number of children who have died from preventable diseases, or who remain buried under the rubble, remains unknown. Starvation continues to plague Gaza City and is now spreading to the south, where children are already living in dire conditions. The nutritional crisis, especially among infants, remains alarming. Months without access to adequate food have had a serious impact on children's growth and development.<sup>3</sup> Over more than a century, this conflict has caused thousands of deaths, millions of refugees, and untold suffering, making it one of the ongoing humanitarian tragedies of our time.<sup>4</sup>

Sharia politics is a part of Islamic law that directly highlights the relationship between society and the state. Therefore, the sharia political view of the establishment of the Palestinian state is considered compatible in detecting the benefits of an action taken by the authorities.

Siyasah Syar'iyyah in the sense of science is a field of study that examines the regulation of society and the state through all forms of laws, rules, and policies made by state authorities in accordance with the spirit and basic principles of Islamic law to achieve the welfare of society.<sup>5</sup>

The fuqaha define siyasah syar'iyyah as government action on a matter in order to achieve a benefit, even if that action has no specific basis in the text. In another definition, they say it is managing human affairs in accordance with the provisions

of the Shariah. Most writings related to Islamic politics define the concept of politics within the scope of these two definitions.<sup>6</sup>

The novelty of this research can be seen through the literature review, namely the results of previous relevant studies. Among the studies relevant to the establishment of the State of Palestine is the perspective of Siyasah Syar'iyyah. George Kyris highlights The Recognition of a Right to Statehood and Palestine.<sup>7</sup> Azwar et al. focus on highlighting Palestine in the Vortex of History and Solidarity of the Muslim Ummah.<sup>8</sup> Meanwhile, Deli Waryenti focused on the legal implications of recognizing Palestine under international law.<sup>9</sup> On the other hand, Yuni Putri Dewantara et al. highlight recognition and legitimacy in international law, focusing on the case study of the Israeli-Palestinian conflict.<sup>10</sup> Ester Nathania Davita Sitanggang, et al. discuss the dynamics of state recognition in international law, namely the analysis of legal and political implications in an era of global dynamics focused on the conflict over the recognition of the State of Palestine.<sup>11</sup>

The fundamental difference from previous studies is that this study specifically focuses on highlighting the establishment of the Palestinian state from the perspective of Siyasah Syar'iyyah. Therefore, based on this novel approach, the results of this study can contribute to the urgency of the existence/establishment of a Palestinian state based on Siyasah Syar'iyyah.

This conflict is not only about territorial disputes, but also concerns human rights, historical justice, and the right to self-determination. The Islamic world generally views this conflict as part of its moral and religious responsibility to support the Palestinian people, although the responses and concrete steps taken by Islamic countries are not always consistent. Meanwhile, peace efforts continue, but often reach a dead end due to differences in interests, power imbalances, and complex political realities.<sup>12</sup> Israel's military aggression against Palestinians requires protection, one of which is from the state.
